

Excelerate Energy

Excelerate Energy L.P. is a US-based liquified natural gas (LNG) company located in The Woodlands, Texas. Excelerate is the pioneer and market leader in innovative floating LNG solutions, providing integrated services along the entire LNG value chain with an objective of delivering rapid-to-market and reliable LNG solutions to customers. Excelerate offers a full range of floating regasification services from FSRU to infrastructure development to LNG supply.



Excelerate is committed to providing markets around the world with access to cleaner energy. The company's mission is to develop world-class LNG products and services that meet or exceed customer requirements and benefit the communities where it operates.

In the News

In June of 2020, Excelerate took delivery of its tenth FRSU, which has a capacity of 173,400 cubic meters of LNG. This vessel will further allow Excelerate to access natural gas markets around the world.

In June of 2020, Excelerate made a large donation to the Hope Foundation for Women and Children in Bangladesh, a refugee camp home to more than a million refugees. This donation supported Covid-19 relief efforts at the camp. In February of 2020, Excelerate was awarded documents of compliance under the International Safety Management Code which authorize Excelerate Technical Management (ETM) to operate as ship manager for Excelerate's entire fleet of FSRUs.

U.S.-U.A.E. Partnerships

In 2015, Excelerate's FSRU was upgraded to provide expanded services at the Jebel Ali LNG Import Terminal to meet rising energy demand in Dubai.

Abu Dhabi charted its first FSRU from Excelerate in 2016, located in the refinery town of Ruwais.

In 2016, Excelerate upgraded Abu Dhabi's existing Ruwais sulfur jetty into Abu Dhabi's first LNG terminal. This upgrade helps fulfill the rising energy needs of Abu Dhabi.
